The Stakeholders Relationship Committee of the Board of Directors of the Company at its Meeting held today, had approved the allotment of 94,968 equity shares of Rs.10/- each, being the exercise of 5,325 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014) and 89,643 equity stock options under the Employee Stock Option Scheme, 2022 (ESOS 2022). Out of 94,968 equity shares allotted in the meeting, 11,250 equity shares were allotted to Mr. Subramanian Sundaresan, the former Chief Executive Officer and 5,625 shares were allotted to Mr. R Ravi Kula Chandran, Chief Financial Officer.

Consequent to this, the paid-up equity share capital had increased from 3,71,87,431 equity shares of Rs.10/- each to 3,72,82,399 equity shares of Rs.10/- each. - ii) The National Stock Exchange of India Limited vide their letter No. NSE/LIST/252389-U dated 9th October, 2014 for ESOS 2014 and letter No. NSE/LIST/32266 dated 01st September, 2022 for ESOS 2022.

The Company shall apply for the listing and trading permission shortly.
