Sub: Allotment of Shares under Company Employee Stock Option Schemes

The Stakeholders Relationship Committee of the Board of Directors of the Company at its Meeting held today, has approved an allotment of 43,256 equity shares of Rs.10/- each, being the exercise of 1,124 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013), 16,505 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014) and 25,627 equity stock options under the Employee Stock Option Scheme, 2022 (ESOS 2022).

Consequent to this the paid-up equity share capital has increased from 3,71,28,748 equity shares of Rs.10/- each to 3,71,72,004 equity shares of Rs.10/- each. - ii) The National Stock Exchange of India Limited vide their letter No.NSE/LIST/252668-7 dated 13th October, 2014 for ESOS 2013, letter No.NSE/LIST/252389-U dated 9th October, 2014 for ESOS 2014 and letter No. NSE/LIST/32266 dated 01st September, 2022 for ESOS 2022.

The Company shall apply for the listing and trading permission shortly.
